WE GOT THE NATION'S HIGHEST PAID STATE LEGISLATURE

When COVID hit and people lost their jobs and businesses closed their doors <u>our State legislators voted</u> <u>themselves a 29% raise</u>.

They are now the highest paid state legislature in the nation at \$142,000 plus they can hold another job at \$35,000.

Let's compare this to other State legislatures such as Florida where they are paid \$18,000 a year, Texas at 7200/yr, New Hampshire at \$100/yr and New Mexico at zero dollars/yr. Yes that's right – in NM they take no salary because their reason for being in office is to work for a better state and not to line their pockets.

The practice of having an employee set their own raises at whatever level and whenever they want is absurd. Our government has forgotten that we, the people, are the employer and the state legislators are our employees. We hire them through our vote. When in office I plan to introduce legislation to mandate raises for state legislatures be voted on by the people at the polls.

Did you know we have some of the most brilliant and diverse minds graduating from our trade schools, SUNY Broome and Binghamton University and yet we do not have the resources to educate them as they deserve; nor due to a crucial gap in our economic development do we have the diversity of jobs to keep them in this area.

This mass exodus of investors, businesses and people is being fueled by policies that have resulted in . . .

High Cost of Living: Housing costs, taxes, and expenses for necessities such as groceries and transportation is significantly higher in NY making it challenging for residents, especially those with lower incomes.

Crushing Tax Burden: New York has the highest tax burden in the nation which strain household budgets and discourage business investment.

High Crime Rates: Soft on crime legislation has impacted residents' daily lives as they fear for their safety.

Bureaucracy and Regulation: New York is known for its complex regulatory environment and bureaucratic processes, which pose challenges for businesses, entrepreneurs, and individuals navigating licensing, permitting, and compliance requirements.

Traffic Congestion & Infrastructure Issues including crumbling roads and bridges.



If you have been the victim of abuse, exploitation, or neglect, you are not alone. 1 in 10 seniors in New York report being abused.

One statewide study estimated that for every elder abuse case reported to authorities, there are 23 cases that are unreported.

And this abuse may come from a stranger, a family member, a caregiver, an institution or the government itself. We need to increase penalties for crimes against the elderly! Elder abuse, both physical and emotional, is a serious and widespread public health and human rights problem. It should be labeled as a hate crime.

Senior safety stands as a cornerstone of my legislative agenda when elected, prompting the immediate introduction of measures to institute a dedicated three-digit hotline.

This streamlined hotline will operate 24/7, staffed by trained professionals equipped to address concerns and offer guidance to callers.

Presently, the abuse reporting number, a long 10 digit number, is limited to extended weekday hours, underscoring the urgent need to extend support and protection to our seniors without delay.

Restoring dignity and safeguarding the well-being of our seniors is paramount.

It's troubling to witness the government's disregard, as highlighted by State Comptroller Thomas P. DiNapoli's audit, exposing unspent funds designated for senior citizen programs, notably during the COVID-19 crisis.

In light of this neglect, I am fully committed to relentless advocacy efforts, ensuring that our seniors are not forgotten and that they receive the vital support they urgently need and deserve.



The poverty rate in Broome County is 28% – well above the US poverty rate of 11.1%

Broome County has more than its' fair share of homeless, including students, veterans and the elderly. I visited many homes where they and their children volunteer at soup kitchens because our government is not doing enough to combat this problem.

By leveraging their insights, along with thorough research and data analysis, I would craft legislation that addresses their needs effectively. Notably, sponsoring Assembly Bill A2965A, which grants a real property tax exemption to veterans with 100 percent service-connected disabilities, would have been both a duty and an honor for me.

Despite the absence of sponsorship from Donna Lupardo, I pledge unwavering support and advocacy for our veterans.

I will never falter in ensuring they receive the recognition and assistance they deserve.

Laws that needs to be repealed.

CRIMINAL PROCEDURE LAW ARTICLE 245

(Discovery) established new, accelerated time frames for the sharing of evidence between the prosecution and defense during the pretrial period that puts witnesses at risk.

With NYS Criminal Procedure Law 2453, an accused robber or rapist or someone who has committed another type of heinous act can be ticketed and released. 35 days later while the accused is walking free and waiting for months before trial, he or she is given the names and home addresses of the witnesses. How safe does that make the witness feel? And remember this is different then the Constitution's right to face the witness where you see the witness in court and can cross examine the witness. This is when the accused is free and walking around with your information in his or her pocket knowing you stand between him/her possibly going to jail or being free. With this law the accused may also be granted the right to come into your home again after being arrested so he or she can better build their defense. This makes you the victim twice!

CATCH AND RELEASE AND SOFT ON CRIME LEGISLATION MAKES VICTIMS OF US ALL.

Imagine going home to find the authorities have hauled off your spouse, your child, or your neighbor without an explanation.

Doesn't it sounds like something that only happens in 3rd world counties!

LAW 10 NYCRR 2.13

Is triggered by a determination of the Commissioner of Health and may be directed towards anyone that the Commissioner deems appropriate.

There is no requirement that the subject individual be afflicted with or a carrier of the disease.

The commissioner determines the terms of isolation including its location and duration. This law authorizes the Commissioner to utilize local law enforcement to enforce isolation orders.

Another law was already on the books.

In 1954 our State legislators were careful to balance the rights of individuals with the safety of the public when enacting Public Health Law Section 2120 for obtaining a quarantine or isolation order. This gave authorities the right to quarantine people to protect society. It did not step on our constitutional rights.
